Quorum was established with all members present. Oversight Coordinator Christin Johnson attended virtually and in person staff attendance was Jail Oversight Specialist Alec Jamerson, Prison Oversight Specialist Christopher Albritton and Special Assistant George Choe. Excused was Commissioner Martha Torney.

- III. (0:01:05) Approval of Meeting Minutes of February 12, 2026.
  - Review of minutes by members. Motion by Chair Patterson to approve February 12, 2026, Open Session Meeting Minutes.
    - i. Motion moved by Commissioner Ibarra and seconded by Commissioner Town.

- ii. Vote: Unanimous approval, motion passed, minutes approved.

**IV. (0:01:41) Monthly Update from Department of Corrections and Rehabilitation Director Tommy Johnson**

- **Work Furlough**

- i. Update regarding incident involving a work furlough individual that resulted in DCR pulling 50 people back from the work furlough program temporarily in an abundance of caution.
- ii. This did not affect anyone who was in the program, anyone already granted parole regardless of the offense committed, and anyone on extended furlough regardless of offense committed.
- iii. Director Johnson to meet with Governor Green to brief on work furlough program.
- iv. DCR notified all employers that individuals pulled from the program did nothing wrong as well as family members or person of contact.
- v. Module 20 is currently being used for work furlough and would go to the new work furlough site and alleviate overcrowding.

- **OCCC Update**

- i. No update to provide and awaiting additional funding to be released.
- ii. Removed 300 beds CTC from OCCC site and made more sense to build the jail with programming, but also to raise the Laumaka work furlough site and to add the beds there.
  - a. Purpose to have one efficient location for supervision to monitor individuals in the work furlough program.
  - b. Efficiency of operation near rail station for transportation.
  - c. Individuals that are released and not in a program or to a loved one, DCR will transport person to a particular location, so they are not wandering around. (i.e. Not walking around in a neighborhood or lost)

- **Legislative Update**

- i. DCR, HPA, and HCSOC were able to draft language pertaining to the Compassionate Release bill.
- ii. Joint letter sent to Senator Fukunaga encouraging her to accept the language for SB2688.
  - a. Language from DCR's policy would allow DCR/HPA to consider a wider range of individuals whose medical conditions would be eligible for compassionate release.

**VII. (0:18:50) Concerns Regarding Mail Interference at the Oahu Community Correctional Center (OCCC)**

- Commission received individual complaint from a person in custody that their mail (i.e. legal mail) being interfered with and DCR was investigating and that complaint was substantiated. Also, other people’s mail was being interfered with.
- Nobody was notified regarding these findings such as judiciary, attorneys, etc.
- HCSOC notified Judiciary, prosecuting attorneys, and public defenders.
- Commission will continue to follow this concern.
  - i. Commissioner Town makes comment
  - ii. Chair Patterson comments on legal mail, grievance boxes, and PREA boxes.
  - iii. Commissioner Browning makes comments regarding violation of federal law, constitutional, and civil rights.
  - iv. Commissioner Browning would like to know what preventive measures the Department takes to prevent this from happening again.

- Native Hawaiians, Makahiki was a time that would celebrate the harvest and have an opening and closing ceremony.
